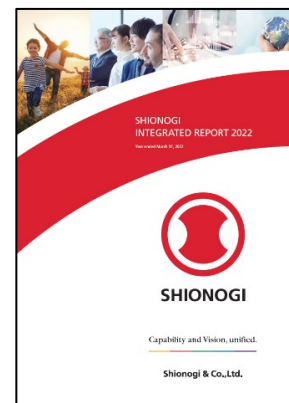




Shionogi Wins Second Prize in NIKKEI Integrated Report Award 2022
