

Shionogi Launches "Endoxan[®] Powder 100mg for Oral" for Nephrotic Syndrome

Osaka, Japan, July 30, 2012 - Shionogi & Co., Ltd. (Head Office: Osaka; President & CEO: Isao Teshirogi, Ph.D.; hereafter "Shionogi") today announced that it has launched "Endoxan[®] powder 100mg for oral" (generic name: cyclophosphamide hydrate) for nephrotic syndrome (limited to be used only on the condition that enough effects are not seen in the appropriate treatment by corticosteroid) in Japan.

The First Committee on New Drugs of the Pharmaceutical Affairs and Food Sanitation Council, held on April, 2011, was evaluated preliminary and allowed to submit an additional indication of former "Endoxan[®] tablets 50mg for oral" which Shionogi has been providing. Shionogi submitted an additional indication of nephrotic syndrome on May, 2011 and received a marketing and manufacturing approval on September, 2011. However, administered dosage for nephrotic syndrome is "Normally for a child, Endoxan[®] should orally be administered 2~3mg/kg a day for $8\sim12$ weeks." So, it is difficult to adjust administered dosage by the former Endoxan[®] tablets. Regarding this additional indication of Endoxan[®], the Investigational Committee for the Unapproved Drugs and Off-label Drug Use with High Medical Needs, established by the Ministry of Health, Labour and Welfare, requested development of a product for children to Shionogi.

Due to reasons like above, Shionogi has developed and launched "Endoxan[®] powder 100mg for oral" which is controllable for administered dosage. Shionogi anticipates the product will bring an appropriate treatment to patients and medical experts and is striving to make contributions to the resolution of the Unapproved Drugs and Off-label Drug Use.
